Dear Sir/Madam,

With reference to your application submitted Online No.SS-00129-0910 and subsequent inspection of the school, I am directed to convey sanction for provisional affiliation to the above said school for Senior School Certificate Examination(Class XI to XII) for a period of three years w.e.f. 01.04.2008 to 31.3.2011 in the following subjects:

The sanction is subject to the fulfilment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes

1. The school should have at least one adequately equipped computer lab with a minimum of 10 computers or computer student ratio of 1:20 and proper software alongwith facility of Broad Band Connectivity with the feature of 'internet always on from any service provider. In case the school is not having the above said facility at present, the school is required to create such facilities within one year from the date of issue of this letter.
2. The school shall promote inclusion of student with disabilities/special needs in the normal school as per provisions of the 'persons with disabilities act -1995'.
3. The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.
4. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
5. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
6. It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
7. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.

8. Annual fee of Rs. 4500/- @ Rs.1500/- per annum for three years (01.04.2008 to 31.03.2011) be also remitted at an early date. (In case of overseas Independent school @ Rs. 5000/- p.a. and overseas Kendriya Vidyalayas @ Rs. 3500/- p.a.).
9. The school will apply for further Extension of Provisional Affiliation 'on online' through www.cbseaff.nic.in with the prescribed fee of Rs. 12,500/- and other essential documents before 30th June of the preceding year before the expiry of the date of provisional affiliation.
10. The school has been granted Upgradation to +2 Level from 01.04.2008. Accordingly, it can start class XI from the academic session 2008-09 and 1st batch of class XII of the school will be appearing at the CBSE Examination to be held in the year 2010.
11. The school shall sponsor regularly its bonafide and eligible students in Boards class X and class XII Examinations from the year mentioned above without break or inform with reasons thereof in writing well in time about the non-sponsoring of the candidates. Failure to do so will lead to suo moto withdrawal of the affiliation of the school for secondary and Senior Secondary Examinations as the case may be.
12. Other conditions are as per Annexure 'A' enclosed.

SPECIAL CONDITIONS/DEFICIENCIES

- i) To ensure that the school shifts to its new building as they claimed.
- ii) Laboratories are to be fully developed as per the norms of the CBSE which are not so, as on date.
- iii) Regular teachers are to be appointed to share the accountability. There is only one PRT is on Regular pay scale.
- iv) Salary and PF are paid as per AWES Rules which are not at par with the State Govt./Central Govt. Rules and these need to be evaluated by the CBSE. Members have very less comments to make in this regard.
- v) Other infrastructure, e.g., black board, furniture, and fixtures are to be upgraded.

The compliance of the above conditions should reach this office supported with documentary evidences within three months from the date of issue of this letter.
